

Tax Prep/Volunteer Income Tax Assistance in Crittenden, Desoto, Fayette, Lauderdale, Shelby, Tate, Tipton, and Tunica Counties. This partnership provides free tax preparation to maximize the total amount of eligible tax credits for low to moderate tax filers. The Free Tax Prep/VITA program was funded through multiple sources: Internal Revenue Service, Cummins, Wells Fargo, Entergy, and United Way of the Mid-South investments. Methodist Lebonheur serves as the lead agent for a pass-through grant from the U.S. Department of Health and Human Services, Office of Minority Health to deploy a project in partnership with the UWMS Free Tax Prep program to increase the number of households receiving free tax preparation services and benefiting from the EITC (Earned Income Tax Credit). Funds were used to support the operation of super VITA sites, mobile tax preparation, a 2-1-1 Information system, a marketing campaign, and volunteer recognition. In the fiscal year ended 6/30/23, over 9,000 tax returns were prepared, returning over \$10 million to Mid-South families.
